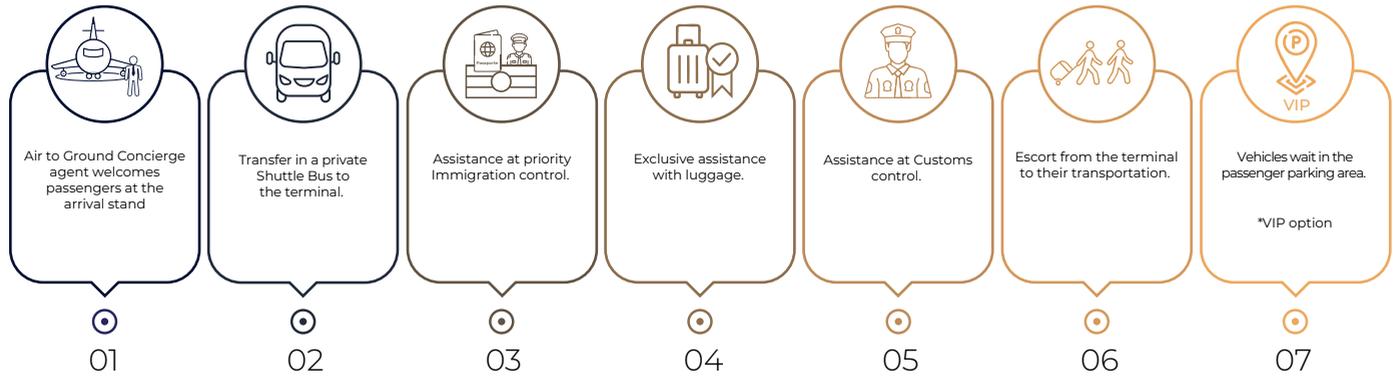


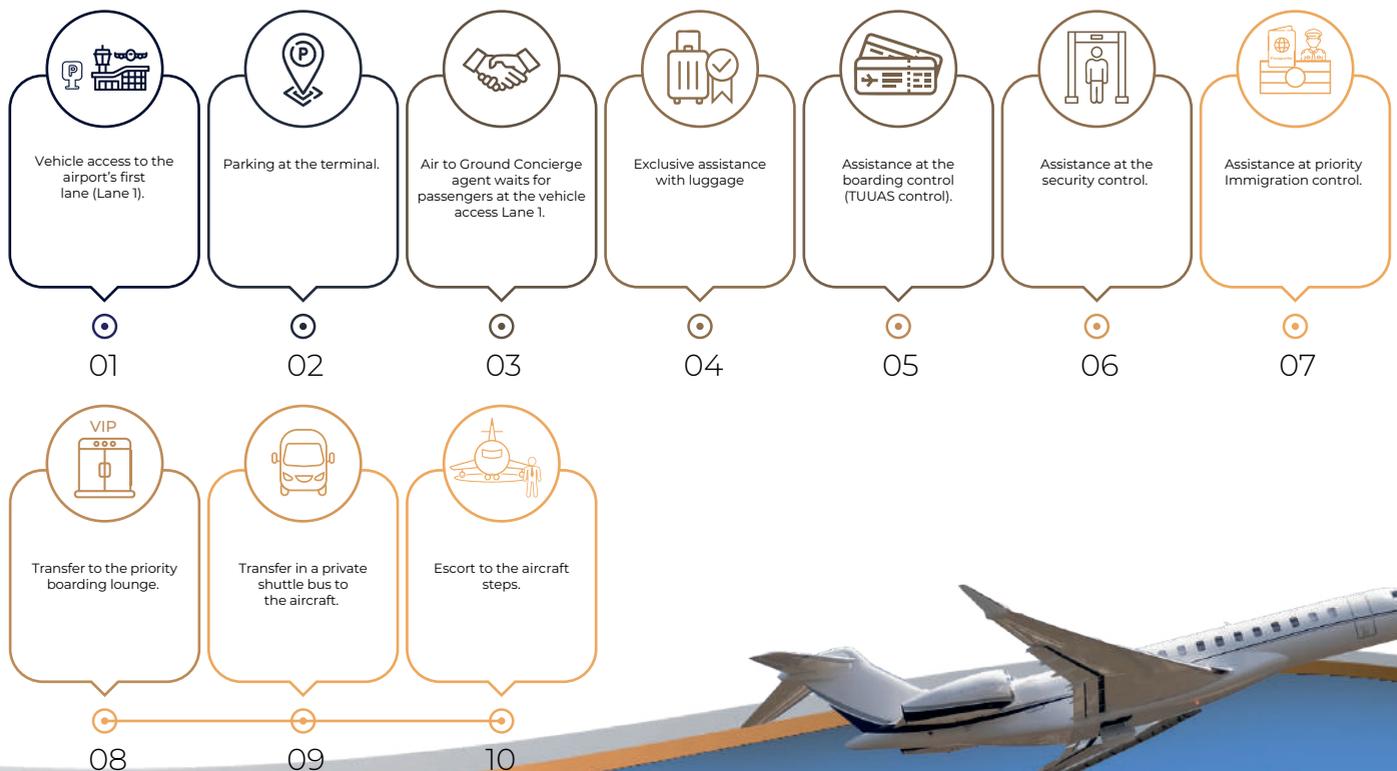

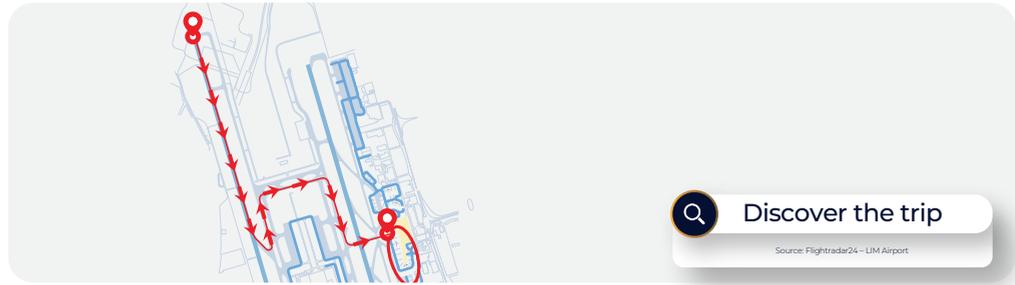
# VIP Concierge Service Notes – Arrival



Step 01:



**Air to Ground Concierge Agent**, waits for the aircraft and passengers at the assigned arrival stand (estimated taxi time: 15 minutes).



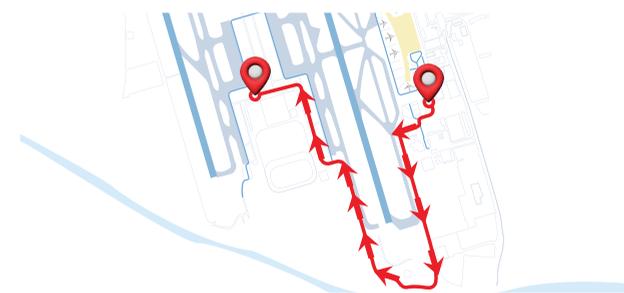

**Transfer in private shuttle bus**, from the aircraft to the terminal to complete the corresponding controls (estimated time: 15 minutes).

Step 03:



Assistance at priority immigration control, passengers are escorted to the control area; the interview with the immigration officer is personal.

**Note:**

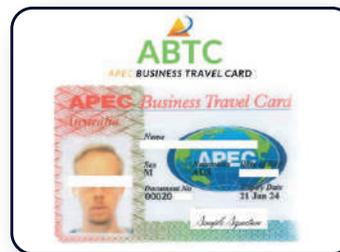
Immigration is an autonomous state entity where priority is given to **diplomatic passports and APEC card holders**. FBO priority requests are subject to the approval of the entity; they have the authority to approve or deny these priorities.

**Useful fact:** Visa and entry procedures depend on each country that requires them via ordinary passports.

# VIP Concierge Service Notes – Arrival



**Assistance at customs control**, support will be provided with luggage handling through the scanner machines.

**Note:**

Customs is an autonomous entity that has the authority to inspect, handle, and seize luggage contents according to its legislation (it is random, at the discretion of the customs officer).

Goods and items not required to be declared and that you can bring duty-free into Peru.

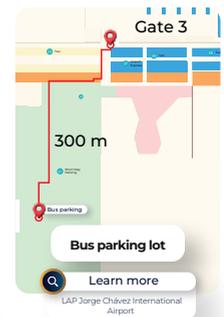

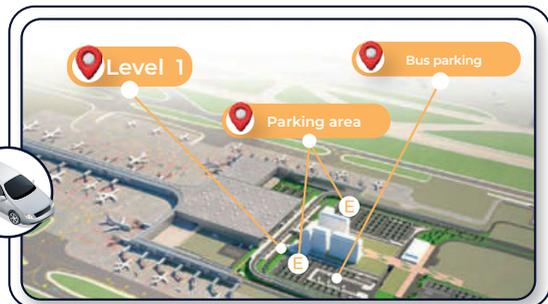


**Vehicles wait in the parking area.**

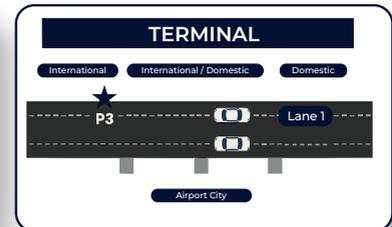

Step 01:



**Vehicle access to the airport's first lane (Via 1)**, with a maximum waiting time of 10 minutes. International departures, third-level ramp, Gate 3.

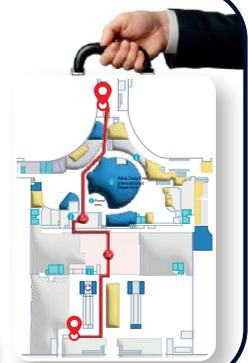

# VIP Concierge Service Notes – Departure



**Assistance at the boarding concourse access (TUUA control),** the passenger will be assisted for access to TUUA control.

**Note:**

The airport fee or Unified Airport Usage Fee (TUUA) is related to the various services provided by LAP to passengers at the Jorge Chávez International Airport facilities, during check-in, boarding, baggage handling, cargo, and mail. (Paid by FBO). (TUUA):

- Airport Tax
- Airport Fee
- PSC (Passenger Service Charge)



**Assistance at the security control,** carry-on luggage is inspected in lines with advanced technology (CT scanners).

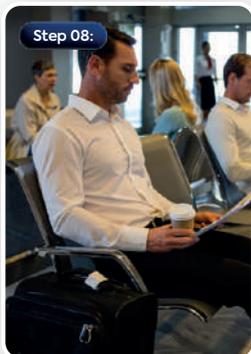
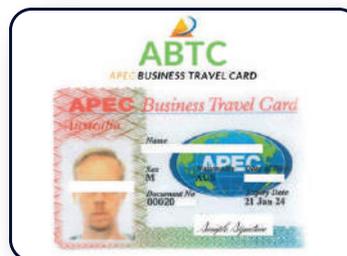
